**Section 2 – ACKNOWLEDGEMENT OF RISK RELEASE AND WAIVER OF LIABILITY**

The undersigned hereby covenants and agrees for himself/herself and any other servant, agent, invitee, guest, spectator, organization, employee, member or any other person or group in any way affiliated with his/her (collectively the "Licensee") in the use of the Facility or participation in any activity taking place at the Facility, that they shall be solely responsible for all claims, demands, damages, costs, expenses, actions, causes of action, whether in law or in equity, resulting from any personal injury, or property damage, or for the loss or theft of clothing or equipment, of the Licensee, however caused, and whether contributed to by the negligence of PLAYERS PARADISE SPORTS COMPLEX INC. or 570 SOUTH SERVICE ROAD INC., its employees, servants, officers, agents, contractors and/or representatives and their successors and assigns.

The undersigned hereby covenants and agrees for himself/herself and any other servant, agent, invitee, guest, spectator, organization, employee, member or any other person or group in any way affiliated with him/her (collectively the "Licensee") will conduct themselves in an orderly manner, and comply will all laws as laid down by the Municipal, Provincial or Federal Governments.

The Licensee further covenants and agrees to indemnify and save harmless PLAYERS PARADISE SPORTS COMPLEX INC. or 570 SOUTH SERVICE ROAD INC., its employees, servants, officers, agents, contractors and/or representatives and their successors and assigns from and against all liability whatsoever resulting from any personal injury, property damage, loss or theft referred to in the preceding paragraph.

The Licensee acknowledges that the activities carried on at the Facility, carry with them an inherent risk of personal injury, property damage and loss or theft of personal property and the Licensee by the execution of this document acknowledges and confirms that he/she is well aware of and understands these risks and is executing this document and participating in activities at PLAYERS PARADISE SPORTS COMPLEX INC. voluntarily. Specifically, I hereby acknowledge that I am aware of the risks and hazards associated with or related to soccer, football, and similar activities played at this Sports Facility. The risks and hazards include, but are not limited to, injuries from collisions with other players, benches, or permanent beams, panels and other structures forming part of the facility; being struck by soccer, footballs or sports balls; and physical contact with other participants, resulting in injuries to the eyes, face, teeth, head and other parts of the body, bruises, sprains, cuts, scrapes, breaks, dislocations and spinal cord injuries which may render me permanently paralyzed.

The Licensee covenants and agrees to be bound by all the rules and regulations from time to time as may be published and provided by PLAYERS PARADISE SPORTS COMPLEX INC. to govern the usage of the facility and all activities conducted therein.

**RULES AND REGULATIONS GOVERNING THE USE OF PLAYERS PARADISE SPORTS COMPLEX INC.**

1. Exits must be kept free from obstruction and congestion in case of emergency.
2. Unless specifically authorized in writing by PLAYERS PARADISE SPORTS COMPLEX INC. no person shall sell, offer, or display for sale, any merchandise in or upon the Facility building or property nor shall any person conduct any trade or business in or upon the Facility building or property.
3. Smoking is not permitted within the Facility building or upon its property save for such areas as may be

specifically designated for same.

4. Food is not permitted to be brought within the Facility or upon its property without the consent of PLAYERS PARADISE SPORTS COMPLEX INC.

5. Alcoholic beverages are not permitted to be brought within the Facility or upon its property. Failure to comply with this regulation will result in the IMMEDIATE cancellation of the permit, notifying of authorities and removal from the permitted area. No refund will apply.

6. The Agreement may be suspended or cancelled by PLAYERS PARADISE SPORTS COMPLEX INC. if it is hindered or prevented from making the facility available for use by the Licensee because of labour disturbances, (including strikes and lockouts), wars, acts of God, fires, storms, accidents, government regulations, or interference of any kind beyond its control. Any monies paid pursuant to the Agreement covering the period for which the Agreement is suspended or cancelled will be refunded to the Licensee.

7. PLAYERS PARADISE SPORTS COMPLEX INC. makes no representation of any kind whatsoever that the same field time will be made available to the Licensee for any other times or periods after the expiration of that period set out in the Agreement.

8. The Licensee may not sub-contract or sub-license its field time without the prior written consent of PLAYERS PARADISE SPORTS COMPLEX INC. The Agreement may not be assigned by the Licensee without the written consent of PLAYERS PARADISE SPORTS COMPLEX INC. The Licensee is strictly prohibited from operating a league of any kind at the Facility without the prior written consent of PLAYERS PARADISE SPORTS COMPLEX INC.

9. The Licensee agrees to compensate the PLAYERS PARADISE SPORTS COMPLEX INC. for any damages to the Facility, its property, fixtures and equipment that occurs during the Licensee's occupancy of the Facility or its use of the same.

10. The Licensee is strictly prohibited from charging any admission fees for entry to the Facility, without the prior written consent of PLAYERS PARADISE SPORTS COMPLEX INC.

11. The Licensee shall restrict activities to the permitted area. Access to other areas is not allowed.

12. The Licensee agrees to vacate the Facility within 5 minutes before the end of their permitted time slot. Player and spectator areas must be left in a clean and usable condition when vacated.

13. The Licensee must provide their own first aid supplies and have group members trained in Emergency First Aid and CPR.

14. The Licensee must receive written authorization from the PLAYERS PARADISE SPORTS COMPLEX INC. prior to affixing any decorations or banners. If granted, the Licensee must ensure all decorations/banners are fireproof, affixed with masking tape and removed by the specified permit end time.

15. The Licensee shall have no right to cancel any of the rental times without the consent of PLAYERS PARADISE SPORTS COMPLEX INC.

16. PLAYERS PARADISE SPORTS COMPLEX INC. reserves the right to refuse admission into or upon the Facility or its property, or to remove any person from the Facility or its property for failure to comply with the terms of The Field Rental Agreement (the "Agreement"), including these Rules and Regulations.

17. The Licensee acknowledges the Facility is monitored by 24 hour video surveillance and any infractions identified herein will be recorded.

18. PLAYERS PARADISE SPORTS COMPLEX INC. may request at any time, to see a government issued form of ID (with photo) from any or all participants utilizing the facility at any time.

19. FAILURE TO COMPLY WITH ANY OF THE RULES AND REGULATIONS CONTAINED HEREIN, OR OF ANY OF THE TERMS OF THE AGREEMENT MAY RESULT IN THE AGREEMENT BEING CANCELLED WITHOUT NOTICE.
